

# Candidate Pledge

I Am A Candidate/or Incumbent for either Federal/State Senator/Representative, and I Pledge the following:

In this email I will ask my Congressional Leader to put these proposed pieces of legislation up for a vote, within the next 30 days. I Pledge to vote for these proposed legislations, that I agreed to support/herein. I will also attempt to have a personal conversation, as quickly as possible, with my Congressional Leader on this matter. In the event that my Congressional Leader fails to bring these proposed legislations up for a vote within 30 days from my sent email, then I shall hold a press conference, and discuss all communications that took place with my congressional leader, express my opinion as to why the proposed legislations were not brought up for a vote. If I have made a “partial pledge”, I will also declare below which #'s (numbers) of these proposed legislations, that I will not support, for full clarity. **I understand that these proposed legislations will need to be tweaked/modified/to be applicable to either State or Federal boundaries/jurisdiction, limits, that are allowable by law, and some may not be applicable to my jurisdiction/State/Federal. I shall tweak and modify to the best of my abilities/as subject to the content in the legislation of what is allowed to be modified/and what is not, before sending the email to my congressional leader.** I understand that a pledge can be made if there are slight disagreements on fines/penalties/not to ever exceed a 35% difference, and that there is no room for compromise on the stated actual types of penalties/qualified immunity issues, and the legal accessible ways to collect these monies.
